# 1 Purpose

This document establishes and provides the formal rules, regulations, procedures, and guidelines which govern controller training operations within the ZDV ARTCC. This document is considered a supplement to any VATSIM, Executive Committee, VATUSA, and ZDV policies, procedures, and controlled documentation.

# 2 Roles and Responsibilities

The syllabus shall be maintained by the Training Administrator (TA). Upon vacating the position, the outgoing TA shall provide the source file of this syllabus to the incoming TA, so that they may continue to modify this syllabus as needed. Policies shall be maintained in accordance with established VATSIM Global Rating Policies. At no time shall any provision in this manual conflict with a VATSIM or VATUSA policy.

## 4 Observer to S1

Initial Review Session for the concepts related to S1 rating.

Timeframe: 5-8 Sessions, 9-12 hours

### 4.7 Denver Major Certification - Class B Ops

The student starts training at KDEN.

Timeframe: 2 sessions, 1-2 hours total Airfield: KDEN

- 20 hours controlling at S1 rating
- DEN Ground exam, prior to full certification. Not required to begin training.

- All other ZDV LOAs (Specifically focus on required routes)
- KDEN airport chart
- 4.7.3 Introduction to KDEN
  - SOP/LOA Reread and Review
  - RNAV SID Review and "Climb Via SID" Phraseology
  - CRC profile for KDEN
  - PDC Pre-Departure Clearance
  - Review airspace classes and entry requirements

#### 4.7.4 Sweatbox

- Student will run through two separate situation files for KDEN on Sweatbox and will continue practicing them until proficiency is demonstrated:
  - DENCD1: IFR / VFR with complete flight plans. VFR aircraft have little information in their flight plans.
  - DENGC1: IFR / VFR with complete flight plans. VFR aircraft have little information in their flight plans.

### 4.7.5 Completion Standards

• Upon completion of this section the student will receive a Denver Solo Endorsement if the student can competently control all aircraft above the normal daily traffic level. If a student demonstrates all competencies proficiency a full certification may be issued at the mentor/instructor's discretion, once DEN Ground exam has been completed.

### 4.8 Denver Major Certification Exam (OTS)

An OTS exam for the Denver S1 Major Ground rating will be administered on the Sweatbox server by an Instructor/Mentor.

### 4.8.1 Prerequisite Qualifications:

- S1 Rating
- Minimum 20 hours controlling as an S1
- Passing score on KDEN Major Ground Exam
- Student has had solo for 10 days and logged 10 hours on the position.

### 4.8.2 OTS Evaluation

- Student will run through the S1 OTS file and will be graded using the Denver Ground Major Standards Rubric
  - Sweatbox File (OTS) DENGC
- Student will be advised of PASS or FAIL score from OTS evaluation
- Upon passing score from OTS exam, student will be issued the S1 Major Ground endorsement for KDEN

### 4.8.3 Completion Standards

- This module will be considered complete assuming that the student has completed all aspects of the Major Certification Rubric to a satisfactory level.
- Upon completion of this module, the student will be awarded a Denver Ground Major Certification.

### 4.8.4 Exceptions

• This module may be combined with the S2 Major Certification in one session for transferring or visiting controllers. Two sessions are only required if the student does the Denver Ground Major Certification when they were not qualified to do the Major Tower Certification at the time.

# 5 S1 to S2

### 5.1 Local Control Basic Class D / C Operations

Student will mainly focus on departures during this standard. This session will take place on the Sweatbox server and should consist of no more than three sessions. This should be an application of material learned on the Academy course, along with reviewing deficiencies.

Timeframe: 3-5 sessions, 4-5 hours Airfield: KAPA, KCOS and KBJC

### 5.1.1 Prerequisite Qualifications:

- S1 Rating
- Student must have completed the S2 Academy Course and Passed the Final Exam

### 5.1.2 Prerequisite Reading:

- KAPA, KBJC and KCOS ATCT SOPs
- VATUSA S2 CBTs (Block 3: Local Control)

### 5.1.3 Introduction to Basic Local Control

The student will be introduced to basic local control concepts at KAPA, KBJC and KCOS. Student is instructed that while this training is taking place at KAPA, KBJC and KCOS, the concepts learned can be applied to any Class D / C field.

- Airspace (types, ceilings, floors, and the "-minus" notations on section charts)
- Traffic pattern legs
- VFR outbound traffic
- Traffic pattern departures
- IFR Departure Release
- Rolling releases (KDEN only)
- Handoff to departure
- Landing / Takeoff clearances and what they mean
- Intersection departures
- Land and Hold Short (LAHSO), Line Up and Wait (LUAW) and runway crossings
- Same runway separation
- Wake turbulence

### 5.1.4 Sweatbox

- Student will run through two separate situations files on Sweatbox: one for KAPA and one for KCOS and will continue practicing with them until proficiency is demonstrated
  - APALC1: KAPA IFR / VFR with a mix of correct, incorrect, and incomplete VFR flight plans
  - APALC2: KAPA IFR / VFR with a mix of correct, incorrect, and incomplete VFR flight plans
  - APALC3: KAPA IFR / VFR with a mix of correct, incorrect, and incomplete VFR flight plans

- BJCLC1: KBJC IFR / VFR with a mix of correct, incorrect, and incomplete VFR flight plana
- COSLC1: KCOS IFR / VFR with a mix of correct, incorrect, and incomplete VFR flight plans

### 5.1.5 Completion Standards

• This standard will be considered complete once the student is able to apply all applicable knowledge from the academy S2 course and control departures with little error.

### 5.2 Local Control Advanced Class D / C Ops.

Student will focus on arrivals and VFR pattern procedures during this. This session will take place on the Sweatbox server.

Timeframe: 1-2 sessions, 2-3 hours Airfields: KAPA, KBJC and KCOS

### 5.2.2 Introduction to Advanced Local Control

Student will be introduced to advanced local control concepts at KAPA, KBJC and KCOS. Student is instructed that while this training is only taking place at KAPA, KBJC and KCOS, the concepts can be applied to any Class D / C field.

  - Legs of the pattern in order
- Landing Clearances:
  - Touch and Go
  - Stop and Go

  - Crossing over the field

### 5.2.3 SweatBox

- Student will run through two separate situation files on SweatBox: one for KAPA and one for KCOS and will continue practicing with them until proficiency is demonstrated
  - APALC1: KAPA IFR / VFR with a mix of correct, incorrect, and incomplete VFR flight plans
  - APALC2: KAPA IFR / VFR with a mix of correct, incorrect, and incomplete VFR flight plans
  - APALC3: KAPA IFR / VFR with a mix of correct, incorrect, and incomplete VFR flight plans
  - BJCLC1: KBJC IFR / VFR with a mix of correct, incorrect, and incomplete VFR flight plana
  - COSLC1: KCOS IFR / VFR with a mix of correct, incorrect, and incomplete VFR flight plans
- A debrief will be conducted on the topics and material that were covered in the training session and any questions will be answered
- New reading material for all Class C / D operations will be assigned.
- Training notes updated

### 5.2.4 Completion Standards

• For this standard to be considered complete, the student must be able to control arrivals and departures, both IFR and VFR mixed at or above normal daily traffic flow.

### 5.3 Class C Tower Solo Certification

Once the student has completed the previous standard, they may be cleared for a solo certification at the training staff discretion.

Timeframe: Minimum 1 hour, Ideal 2-5 hours Airfield: KCOS

### 5.3.1 Prerequisite Qualifications:

• S1 Rating

### 5.3.2 Solo Certification

- Only valid for 30 days
- May be extended up to times, to a maximum of 90 days, with Training Administrator approval.

### 5.4 S2 OTS

#### 5.4.1 Prerequisite Qualifications

- Recommendation for OTS from Mentor/Instructor
- VATUSA S2 Academy Course Completed and Passed

### 5.4.2 OTS Elements

- All Line items for the S2 OTS are outlined in the S2 Rating Review form, not available to students. The student will be briefed online items to be satisfactory in.
- The OTS should be conducted on the live network upon the instructors wish. Sweatbox is an option if need be.
- Potential Airports: KAPA, KCOS, KGJT, KBJC, KPUB; at the instructor's discretion. Student will be notified a minimum of one hour prior to the session of OTS airport to allow sufficient time to review SOP.

#### 5.4.3 Completion Standards

- For this standard to be considered complete, the student must get a satisfactory rating on all line items.
- At completion the OTS, the student must be awarded an S2 rating. If unsatisfactory, remedial training must be completed prior to the next OTS.

### 5.5 Tier 2 Complex Procedures Aspen

Student will focus on arrivals and VFR pattern procedures during this standard. This session will take place on the Sweatbox server.

Timeframe: 1-2 sessions, 1-2 hours Airfields: KASE

Student starts training at KDEN. At least two sessions are to be conducted here: at least one session on Sweatbox and one session on the live network. An OTS exam and/or checkout by an instructor or Mentor is required prior to being able to control solo at KDEN, regardless of one's rating.

Timeframe: 2-4 sessions, 5+ hours Airfield: KDEN

#### 5.7.5 Completion Standards

• For this to be considered complete, the student must be able to control KDEN at an above normal traffic level to a sufficient standard deemed by the mentor/instructor.

- The Major Certification Rubric should be referenced by the mentor/instructor to deem a sufficient standard.
- Upon Completion this standard, the student will be awarded a solo endorsement expiring 30 days from the date of issuance.

### 5.8 Major Tower Checkout

A major checkout for the KDEN Major Tower Endorsement will be administered live on the network or in a sweatbox environment by an instructor or mentor. It may be conducted during an event assuming that a mentor or instructor is monitoring throughout.

Timeframe: 2 hours minimum

### 5.8.1 Prerequisite Qualifications:

- 10 or more hours recorded on DEN\_TWR
- 5.8.2 OTS Evaluation

### 6.4 S3 OTS

For the S3 OTS, traffic must be conducted at or above a daily traffic level at a field chosen by the instructor. It should be noted that a student who has done more than 50% of their training with one instructor shall not conduct an OTS on the same student. It needs to be conducted by another instructor.

Timeframe: 2 hours, 1 Session Focus TRACON: Any at Instructor Discretion

Student will be introduced to departure concepts in a Class B TRACON environment. The D01 require significant work and practice, however, training will begin with KDEN departures and then layer on more complex scenarios with each.

Timeframe: 2+ hours, 2+ sessions Focus TRACON: D01

- 6.7.2 Prerequisite Reading:

### 6.7.3 SweatBox

Student will be introduced to arrival concepts in a Class B TRACON environment. The Finals Box should be taught separately to the feeder routes.

Timeframe: 3+ hours, 3+ sessions Focus TRACON: D01

- Student will run through two separate situation files for D01 on Sweatbox and will continue practicing with them until proficiency is demonstrated:
  - D01 Arr Dep: IFR KDEN departures and arrivals including satellites, "top down"

    - Recommend VIV or IVI ILS/Visual Procedures Practice.
- A debrief will be conducted on the topics and material that were covered in the training session and any questions will be answered

#### 6.8.3 Completion Standards

• For this to be considered complete, the student must be able to independently control the feeder sector of D01 without assistance with event level traffic. This is to include controlling a daily to above daily level of traffic for all arrival sectors, and event level traffic for the feeder and finals box.

### 6.9 App / Dep D01 Live Monitoring

Student will connect to the live network under the supervision of a Mentor / Instructor. The student shall put in at least 10 hours of controlling time at the TRACON, although more time is encouraged.

Timeframe: 10+ hours Focus TRACON: D01

### 6.9.1 Prerequisite Qualifications:

Passing score on the S3 D01 Major Facility Rating exam

Upon completion of this, a solo cert may be awarded at the discretion of the mentor/instructor.

### 6.10 App / Dep D01 OTS Exam

An OTS exam for the D01 Major rating will be administered live on the network by an instructor.

Timeframe: 1 Session, 3 Hours Focus TRACON: D01

### 6.10.1 Prerequisite Qualifications:

• S3 Rating

### 6.10.2 Checkout Evaluation

• The student must be given a file with departures and arrivals into Denver, and Satellite departures and arrivals. The student will control top down to demonstrate the knowledge of airspace.

#### 6.10.3 Completion Standards

• For this to be considered complete, the student must get a satisfactory rating on all aspects outlined in the Denver Approach Major Certification Standards Rubric located in the Training Academy Drive.

# 7 S3 to C1

### 7.1 Sequencing Practice

When a student expresses interest in beginning C1 training, they will be issued the ZDV C1 Knowledge exam. This exam will test the student's ability to use their resources. All answers to questions in this exam can be found in the documentation on either VATUSA or ZDV websites. **Due to the requirement by GCAP to provide "top down" services as a Center, the student must be S3 Tier 1 certified to begin C1 training.** 

To gain experience in sequencing arrivals into a busy airport, the ZDV Sweatbox files for Areas 1, 2, 3,4, and South files must be ran until a satisfactory completion deemed by the mentor/instructor for the student to be put up for an OTS.

### 7.2 Enroute - Live Monitoring Denver Center

Timeframe: 10+ hours

### 7.3 Enroute OTS Denver Center

An OTS exam for the C1 rating will be administered live on the network by an instructor. A supervisor will announce the OTS and the student will be graded using the OTS rubric.

Timeframe: 1 session, 2-3 hours

#### 7.3.1 Prerequisite Qualifications:

- S3 Rating with D01 Major Endorsement

#### 7.3.2 OTS Evaluation

• The student will be on the live network for all the OTS. The student must do all the work by themselves for this OTS.
